CBIA fees are administered on a calendar-year basis. A member's initial fee, therefore, is prorated based upon the time of year membership begins. See table below for first-year charges:
 1st quarter (Jan., Feb., March) – 100 percent of fee quoted at left
 2nd quarter (April, May, June) – 75 percent
 3rd quarter (July, Aug., Sept.) – 50 percent
 4th quarter (Oct., Nov., Dec.) – 100 percent (includes following year's fee)

* for annual total CT payroll of \$1,000,000 or over:
 \$750 + (30¢ per \$1,000 of payroll in excess of \$1,000,000). \$27,000 is maximum fee

For federal income tax purposes, membership dues to CBIA are deductible as business expenses, not as charitable contributions. Lobbying expenses are not deductible for federal tax purposes. Approximately 30% of dues is used by CBIA for lobbying activities, including grassroots advertising. This portion of your dues is therefore not tax deductible. Dues, once paid, are not refundable. Your membership fee includes \$9 earmarked for one subscription to the CBIANews. Additional subscriptions may be obtained at the same rate by contacting CBIA.
